2.	<p><b>Payment of Annual Tuition Fee by 2<sup>nd</sup> &amp; 3<sup>rd</sup> year Postgraduate students</b></p> <p>The <b>tuition fee</b> amounting to <b>Rs. 15,600/-</b> (fifteen thousand six hundred only) is required to be paid by <b>Postgraduate students</b> for the <b>2<sup>nd</sup> year</b> and <b>3<sup>rd</sup> year</b> of the course by <b>14<sup>th</sup> of May every year</b>.
